

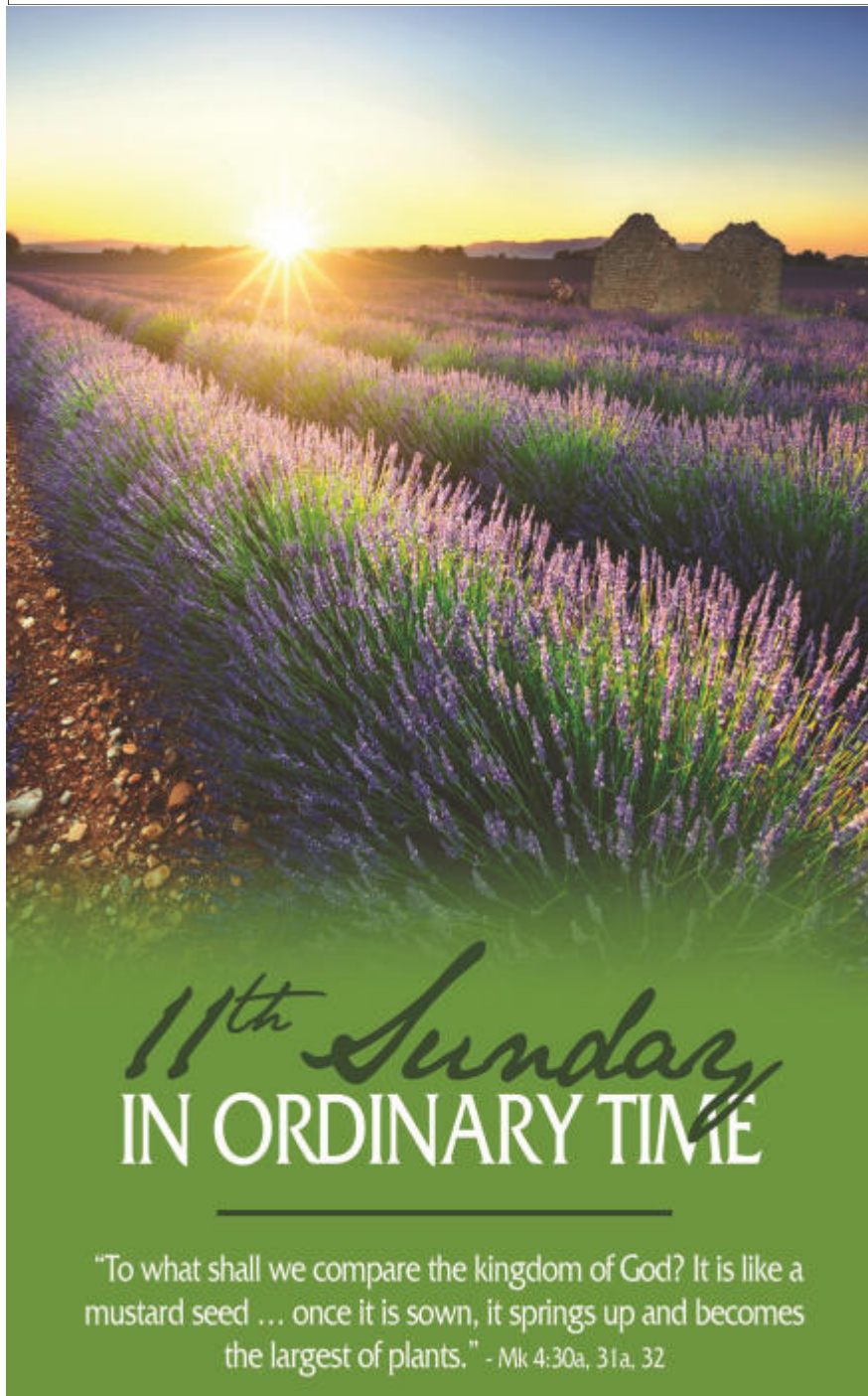

THIRD NOTICE OF TRUSTEE NOMINATION

It is time for the selection of a Parish Trustee, one of the positions of the Parish as a legal corporation/entity, takes place. There are two parish trustees, Christopher Gauthier and Lenny Schaefer, each serving renewable two year terms. The term of **Chris Gauthier** is ending this year.

According to Archdiocesan policy on Trustee Nomination:

- Trustees must be parish members, practicing Catholics and at least 25 years of age.
 - Bylaws require that trustees be **elected** every two years, by the parishioners, to serve a two-year term. Trustees serve until their successors are elected.
 - Parish staff and permanent deacons are not eligible to serve as trustees.
 - The archbishop, as president of the corporation, has the right to approve or disapprove any lay trustee elected by the parish or appointed by the pastor to succeed or to fill temporary vacancies or unexpired terms.
 - One trustee is designated as the trustee-treasurer and the other as the trustee-secretary.
 - Trustees are ex-officio members of the parish council and participate fully in the work of the council.
 - Trustees may not hold office on the parish council nor should they serve as chairpersons of parish committees or liaisons to committees.
 - At least one trustee (usually the treasurer) along with the pastor must sign each check issued by the parish.
 - Parish trustees are not to initiate or respond to any lawsuit in the name of the parish without the written permission of the archbishop.
 - The trustee-treasurer is an ex-officio member of the Finance/Administrative Services or Finance Committee.
- Additional candidates must be nominated in writing by 10 or more parish members.

- If there is more than one candidate, an election will occur in June.

With his consent, I am nominating **Chris Gauthier** to serve as parish trustee for a term of two years. If anyone else is interested, kindly submit a nomination as per the above stated regulations. Nomination forms are available with Lori Gabert at the parish office.

11th Sunday in Ordinary Time June 13, 2021



As we enter back into Ordinary Time, our readings today remind us that heaven is our true home and that we cannot make it there without God's assistance. from the Parish: Living the Gift of Sunday

INTRODUCTION

“It is my hope that you will utilize this book to enliven your prayer and appreciation for Sunday over the next ten weeks. Living the Gift of Sunday is a great gift for us, and how we might live that gift out in our everyday lives. It is meant for individual reflection, but could also be used with your family or as the basis of a small group discussion.”

“**The Church draws her life from the Eucharist,**” Pope Saint John Paul II wrote this short but meaningful phrase in his encyclical letter *Ecclesia de Eucharistia* (7). The early Christians even at risk of being misunderstood and in the face of persecution and death, faithfully proclaimed “*Sine Dominico non possumus* - **we cannot live without celebrating the Lord’s Day**” (Cf. St. Justin Apologia I, 67, 3-5; PG 6, 430; Acta SS. Saturnini, Dativi et aliorum plurimorum Martyrum in Africa, 7, 9, 10: PL 8, 707, 709-710).

“Each Sunday is a participation in the very action of Christ himself, and we encounter the living God alive in our midst. At the very beginning of Mass, we make the Sign of the Cross. We may take this prayer for granted. We may pray it with profound devotion. For us as Christians, it is a reminder that we are caught up in the love of the Blessed Trinity itself, as we recall the very instrument of our salvation.”

“It is impossible to limit what Sunday is and what we religiously bring to our worship of God each week. This booklet is a starting point to invigorate our appreciation for what Sunday is and what the Blessed Trinity accomplishes in and through our lives filled with grace.”
