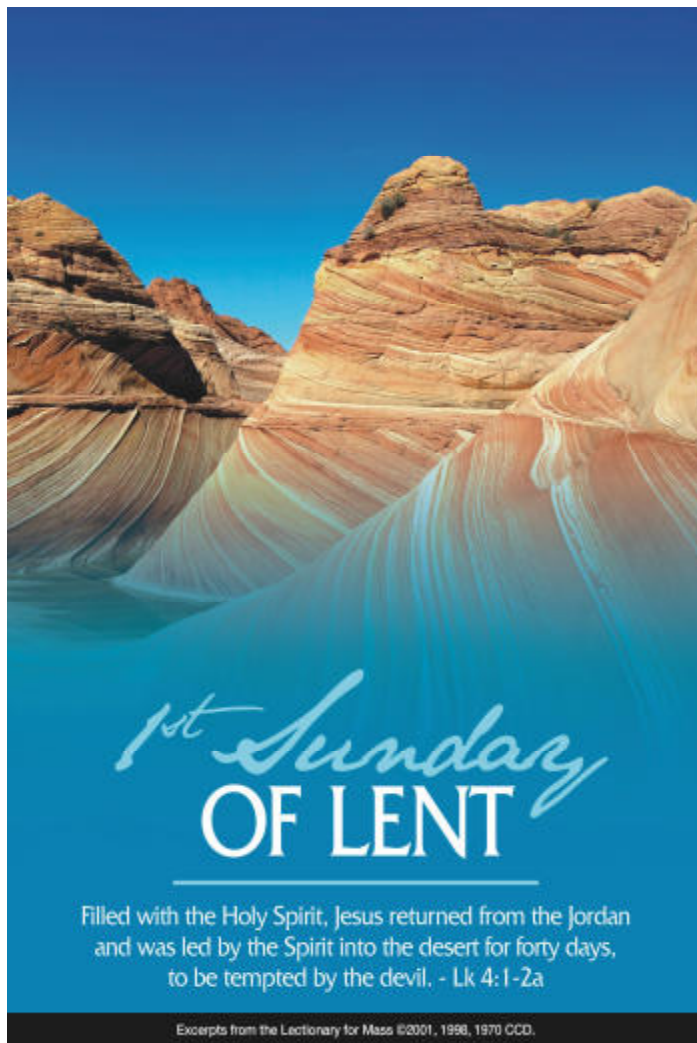

Gospel Reflections... LENT AND HOLY WEEK IN GUATEMALA

The Lenten season is defined as a time of prayer, penance and fasting for Catholics. It has as its starting point Ash Wednesday with the imposition of ashes - an ancient ceremony at the Catholic liturgy. These ashes are made from palms blessed last year on Palm Sunday. In this sense they remind us of the need for ongoing penitence and the mortality of the human being. When the ashes are placed on the forehead by the priest with the following phrase taken from Genesis 3:19 "*Memento Homo, quia Polvis es et in pulverem revertis*" which means; "Remember man that you are dust and to dust you shall return" the phrase reminds us of both the mortality and penitent character of our humanity.

Lent and Holy Week in Guatemala are richly significant in the liturgical calendar for Guatemalan Catholics. Traditionally, it is one of the most anticipated celebrations and expressions of faith and devotion. Unique to Guatemala, is the inclusion of all five senses referencing the historical and anthropological aspects of their culture. The smell of the corozo flower and incense are symbols that announce the funeral processions and purple color floods Guatemala. The flavor of meals prepared by laborious hands of the Guatemalans include traditional cod. All of these beautiful processions and blankets of flowers unite the country in this special season of the Church.
