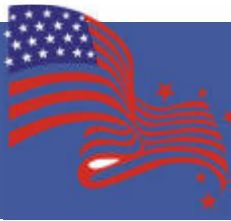

*End of Life Issues*

I remember rushing back the 500 miles from Omaha to Chicago where my dad lay dying. He was the most awesome dad! I respected him tremendously and always hoped that I would grow up to be like him. And now he was dying.

When we finally arrived, much to our surprise, we saw that he had been placed on a ventilator. My dad had been suffering from end-stage emphysema for several years. Even with oxygen around the clock, sometimes each breath was a horrible struggle. There was nothing more that the doctors could do for him. His chart was marked "do not resituate" and yet there he was hooked up to a machine. I don't know how that happened, but it left us in a crisis.

How could we ever tell the doctors to take my dad off the ventilator? It broke our heart. So we turned to the Church to help us navigate these horribly hard decisions. My dad had been a faithful Catholic all his life. We wanted to honor his faith and follow the teachings of the Church.

It was a tremendous comfort to find that the Church had clear cut guidelines to help people in situations just like us. Fortunately the doctors weaned him off the ventilator. We visited with him, and he died naturally a couple weeks later.

Five years later we had similarly distressing experience with my mom but at the opposite end of the spectrum. She had had a stroke and the doctors wanted to withhold the food and fluids from her. This is not okay with the Church. What we do should never be the cause of death.

Eileen ran into a situation just a couple months ago with her mom. We arrived at their house late one Sunday afternoon and about fifteen minutes after we arrived, her mom, Peg, had a "mini-stroke." Eileen stayed with her in the hospital overnight. The nurse kept asking Peg to fill out some living will papers. She kept telling the nurse that all her papers were already on file with the hospital. The next day Eileen found out that somehow things had gotten all confused and that lavender band around her mom's wrist was a "DNR" band. It didn't even say "DNR" – and this was totally against her wishes. How did that happen?

It's confusing out there! The Living Will has many internal flaws, including ambiguous and confusing language which may be interpreted by physicians in a way you did not intend. The WI Power of Attorney for Health can be used to permit euthanasia by omission. What form should we have?

Come learn what the Church teaches and which forms are best to protect you and your wishes. Dinner begins at 6pm on Thursday, May 23, followed by presentations by Dr. Robin Goldsmith and Attorney Greg Vanevenhoven. Please RSVP to the parish office by May 21 so we have enough food and updated forms for all attending.
