

PASTOR'S CORNER



I was raised in Plymouth, Wisconsin. My parents deserve a special accommodation for raising four boys who were not saints by any stretch of the imagination. My mother passed last year, and my father remains the patriarch of the family.

My vocation journey began in high school at St. Lawrence Seminary Mt. Calvary

where the seed was tended to with prayer and discernment. My journey continued when I entered the College Formation Program at St. Francis De Sales Seminary while attending Marquette University. I earned a BA in Interpersonal Communications with a minor in Philosophy and Theology. The strong relationships I forged during the formation program still exist today.

My spiritual journey has not been linear by any means. As my spiritual director has gently reminded me throughout the years, "God draws straight with crooked lines." Discernment led me to St. Norbert Abbey in Green Bay, Wisconsin, where I entered the novitiate and taught at Abbot Pennings High School in De Pere, Wisconsin. In 1990, I was sent to Rome to study at the Pontifical University of St. Thomas Aquinas, and I received my bachelor's degree in Theology. Shortly after, I was ordained to the priesthood on May 7, 1994.

Prayer and discernment led me back to the Milwaukee Archdiocese as the assistant pastor at St. William Parish. Subsequently, I became pastor of St. Veronica Parish. After a brief but rewarding time as administrator of Our Lady Queen of Peace, Archbishop Jerome Listecki appointed me pastor of Blessed Sacrament – a special community that nurtured my faith and vocation for the last five years.

While there are many accomplishments the staff and I achieved during my tenure at Blessed Sacrament, I am particularly proud of the online faith community we established via online masses. We were determined not to let COVID keep God's people from gathering to celebrate our precious liturgy. Blessed Sacrament has over 10,000 subscribers throughout the world – a testament to the power of collaboration between colleagues and pastor!

Throughout my 28 years of priesthood, I have been blessed with many joyful experiences. One experience is my ministry with Heart of the Nation Television Mass. Heart of the Nation produces and televises weekly Sunday Mass nationwide,

providing compassionate spiritual care for Catholics unable to participate in holy Mass at a parish. I am profoundly humbled by the countless number of parishioners who have shared with me how important the TV masses have been in lifting their spirits during their hospital stays or while recuperating from illnesses at home.

When first approached by Executive Director Bruno John to be a part of this important television ministry, I turned down his invitation. I had enough on my plate leading a vibrant parish. "God's ways are not our ways." Bruno would not take "no" for an answer, and I acquiesced to his – God's- wishes. While celebrating my first television Mass, I found myself very much at home with this ministry. Soon after, I accepted his invitation to be chaplain. Over the years my involvement with Heart of the Nation has evolved and been grace-filled. I am incredibly grateful that Bruno and God were persistent.

I also serve the Archdiocese of Milwaukee as a canon lawyer. Who would have thought I would be a canon lawyer? Certainly not me! God may have blessed me with a strong intellect, but not good study habits. Those who know me cannot imagine me silent in a library. Reading scholarly articles and authoring research papers do not come naturally to me; however, I am grateful I accepted the Archbishop's generous invitation to study canon law. As a result, I have had the good fortune of collaborating with the talented individuals in the Archdiocesan tribunal as Adjutant Judicial Vicar and the privilege of rectifying situations that prevent Catholics from full and active participation in the life of the church. Recently, I was appointed Judicial Vicar of the tribunal. I am humbled by this appointment, and I will need your support to honor the responsibilities that come with this assignment as I collaborate with you to make St. Eugene's and St. Monica's the best faith communities God calls us to be.

The reflections I shared with you are just the tip of the iceberg. My 28 years of priesthood has been wonderful, challenging and filled with many blessings. Where will my vocation journey take me in the next few years? Only God knows; "God draws straight with crooked lines." What I do know is that I am thrilled that my faith journey now includes the staff and parishioners of St. Eugene's and St. Monica's. And a special thank you to all of you for welcoming me on your journey. God bless you!
