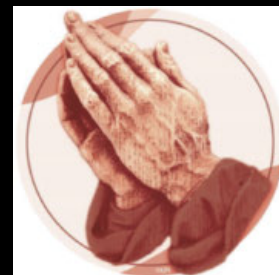

Love Thy Neighbor

The Fourth of July commemorates the signing of the Declaration of Independence in 1776, which announced to the world that the newly named “United States of America” had declared its independence from Great Britain. July 2 also marked the anniversary of another major step towards freedom and equality for all US citizens -- the Civil Rights Act of 1964. That law prohibited segregation in public places and banned employment discrimination based on race, color, religion, sex or national origin. Archbishop Kurtz, the president of the USCCB at the time of the 50th Anniversary of the law passing, noted “The Civil Rights Act was a monumental step forward and since then, we have made even more progress in this vital work of transforming hearts and minds, but there is still much work to do.... We must therefore continue to work against the destructive influence of racism....” As people of goodwill have done throughout our country’s history, may we continue to strive for more perfect “liberty and justice for all”.

Judge Derek Mosley will lead a discussion of Unconscious Bias. We all hold some form of unconscious bias, and the key is to recognize that we have it and employ techniques to mitigate it.

Judge Mosley graduated from Marquette University Law School in 1995. He served as an Assistant District Attorney for Milwaukee County from 1995-2002. While serving as Assistant District Attorney, Judge Mosley founded the Milwaukee County District Attorney's Community Prosecution Unit. This unit places assistant district attorneys in various neighborhoods throughout the City of Milwaukee to work with residents to reduce urban blight and to improve the quality of life. In 2004, Judge Mosley was appointed Chief Judge of the Milwaukee Municipal Court.
