Reflection from Deacon Rick

Resurrexit, sicut dixit! This Latin phrase means
"He is risen, as he said!"

Everything we do as Catholics, as Christians of other traditions, that is, all who profess a belief in Jesus Christ, we hang our hats, so to speak, on the reality we celebrate on this great and solemn feast: that Jesus, after his death on the cross, was raised from the dead. How we understand the Church, how we read, interpret, and understand Sacred Scripture, how we choose to live a moral life: none of these make any sense at all unless we're firmly grounded in this belief. Otherwise, we're going through pointless motions, we're pretenders, posers.

Jesus didn't come into this world, teach, suffer, die, and be raised from the dead to make a bunch of pretenders. He came to make disciples. And when, at the end of Matthew's Gospel he said, "Go, therefore, and make disciples..." he sent us out on a mission, all of us, not just a few of us. Not just the professional holy people. Each and every one of us is called, sent, to make disciples. In its shortest form, this is the mission for which the Church was formed. it wasn't a suggestion, a recommendation, it was, it IS a command.

This Easter, as we commemorate the good news of the empty tomb, knowing that Jesus rose from the dead, we celebrate that universe changing event. And we do that best when we share that good news with others, when we engage in the process of making disciples. And that process begins with each of us. We can't make disciples unless and until each one of us becomes a disciple.

He is risen! He is risen indeed! Believe that, then get on with the mission!

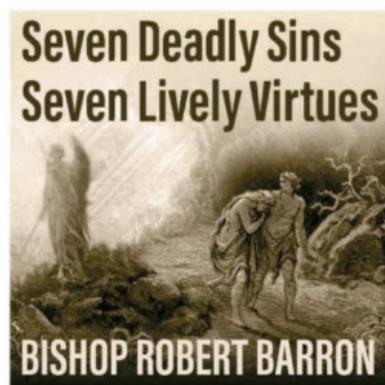

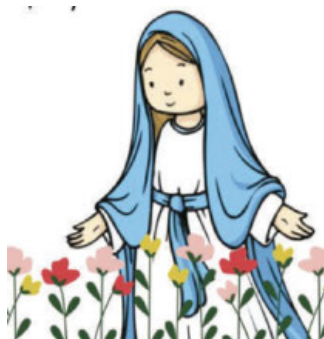

Holy Family Catholic Church in Woodruff

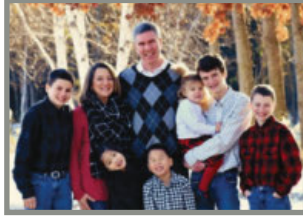
