Ukraine is facing a humanitarian crisis following Russia's invasion on February 24, 2022. The conflict has killed thousands and forced millions to flee their homes to neighboring countries. It is heartbreaking!

Several have asked if we are taking up a second collection. The bishop has decided that there will not be a diocese-wide collection, but if a parish decides to take a collection that is permitted.
