CONFIRMATIONS!

Dads and Moms, we offer confirmation class to students every other year and it has been a year and a half so it is that time again. Fr. Dow has agreed to teach a class to the students to prepare them for this sacrament. The classes will be on Saturdays at 10:00 AM, beginning on September 13th. All students need to be 12 years old by Dec. 1st of 2025 to receive confirmation. The date of confirmation is TBD but it will be around the beginning of December. Everyone who wishes to receive confirmation in December must take this class. If this is impossible for some reason, please give us a call. The sign-up link for confirmation class is on Flocknote.

Preparing to the Receive the Sacraments at All Saints:

- **Baptism**
Ideally the child will be baptized within the first month of birth. The godparents must be practicing Catholics in good standing. Please contact the parish office **after the birth** of your child to schedule his or her baptism.
- **Marriage**
Please arrange at least six months in advance of the anticipated date so that pre-Cana instruction with a priest can be completed. Available for **registered and attending parishioners only**. Please contact the office to make arrangements.
- **First Communion/Confession and Confirmation**
First Communion/Confession and Confirmation will be announced in the bulletin and on Flocknote. First Communions are typically held once a year in the spring, while Confirmations are held once every two years in the winter. (The last Confirmation ceremony took place December 2023.) Available for **registered and attending parishioners only**.
- **Convert Instruction**
Converts are received into the Church on an individual basis. Please contact the office to schedule an interview or instruction with a priest.
