

This is the 4th Sunday of Lent. As we hear the scriptures today we may be called to ponder reconciliation. Reconciliation draws us into a deeper God-relationship. During this lent, are we reconciling our earthly lives with God. At the end of each day do we examine our day to determine when we may have disrupted our God-relationship and when we have improved our God-relationship? One of the ways we can build our God-relationship is through Centering prayer. Tilden Edwards, a spiritual teacher and co-founder of The Shalem institute says "Quiet contemplative prayer happens when we are still and open ourselves to Christ's spirit working secretly within us, when we hear the psalmist's plea: Be still and know that I am God."


