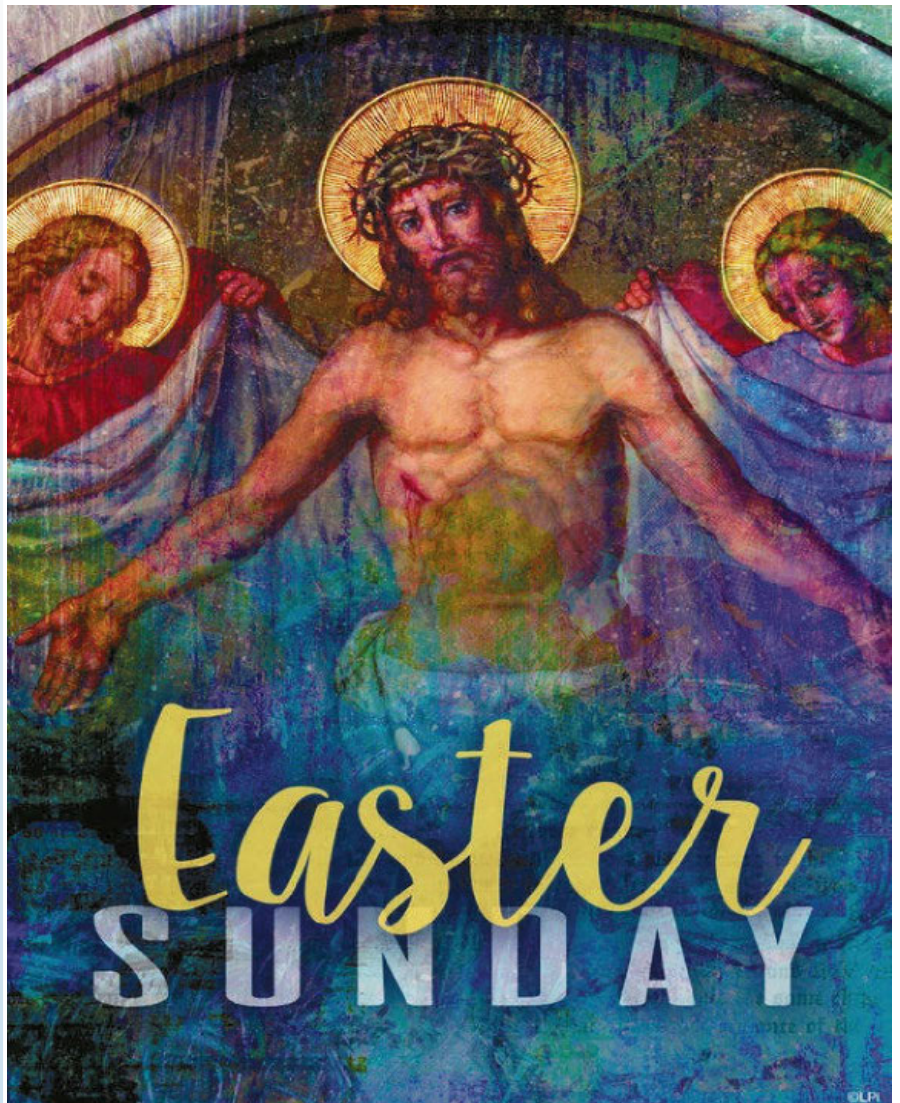

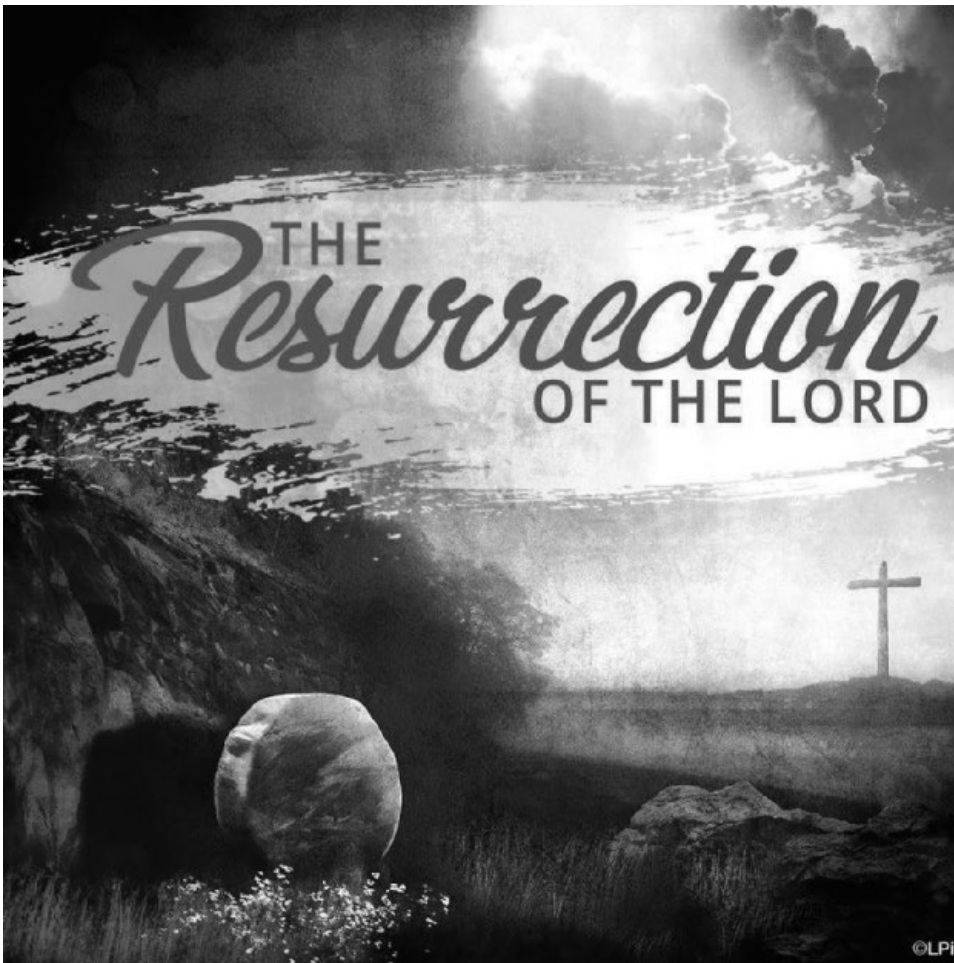

As we spent time over the past couple weeks meditating on the image of Jesus, crucified, we were likely filled with a realm of emotions, from sadness to gratitude. In the past I could only find myself feeling sad and angry that Jesus gave up his earthly life in such a cruel way. I realize that I have only been looking at the crucified Christ from the perspective of His suffering not looking at the image as Christ resurrected. Jesus' outstretched arms can portray the love He has for all of us. He may be reminding us that He died for each and every one of us. He may be calling all of us to come to Him in order that we may share in His divine life. While I meditate with the crucifix in my hand I can now see both the pain of the suffering but also the invitation to be loved by Jesus and offer love to others.
