Dear Friends,

I pray you all had at least a semi-restful Christmas season! I had the opportunity to go to Minneapolis for a few days after Christmas to visit a classmate from the seminary, and will be joining Fr. Johnson later this month for a retreat just outside Chicago.

Fr. Johnson has asked me to assist with our confirmation prep this year. Confirmation will be on April 28th. As in years past, we'll be combining with St. Andrew's parish in Gladstone, which is where the sacrament will take place.

Many of the parents of those who are ready to be confirmed have inquired about us offering something as a parish to help prepare our young people to receive the sacrament. For any current high school freshmen or sophomores who are ready to be confirmed, I will be offering a short 6-session confirmation course in March on Sundays and Wednesdays.
