Good People of Good Counsel,

Here is our schedule for Holy Week:

Tuesday of Holy Week: Holy Hour with Meditation – 7pm

Wednesday of Holy Week: Tenebrae – 6pm

Holy Thursday: 7pm (with adoration of the Blessed Sacrament after Mass)

Good Friday: Noon Service, 3pm Stations of the Cross

Easter Vigil: 9pm

Easter Sunday: 8am, 9:30am, 11:00am

Next week is Palm Sunday. This is one of the lengthier liturgical celebrations, with the blessing of palms, a possible procession, and the reading of the Passion. With an added Sunday Mass on our schedule, we only have a small window of time in between our Masses.

So that the Masses end with enough time for the next Mass to begin, the 8am and 9:30am Masses on Palm Sunday will include some options aimed at keeping the overall Mass time down (such as reading the Passion instead of chanting it). All Masses will have palms and will be still be celebrated with proper solemnity.

If you are interested in attending the most full of the Palm Sunday Masses, the 11am Mass will have the choir singing, and the Passion chanted by Fr. Mattingly, Michael Mills and seminarian Paul Harrison.

I hope everyone continues to have a sacrificial and spiritually fruitful season of Lent as we prepare to enter these most holy of days. Be sure to continue to pray for the four people being baptized at the Easter Vigil.

You have been great about inviting friends who have questions about the Catholic faith to attend one of our Inquiry sessions. Those have continued to grow and more people are discovering the beauty of the Catholic faith. A new round of Inquiry sessions begins on Monday, April 12th. They happen in the parish hall and are open to any non-Catholics who have questions or are curious to learn more about the Catholic faith. I invite everyone in the parish to consider if there is anyone in their life that might benefit from coming.

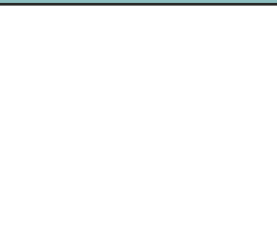

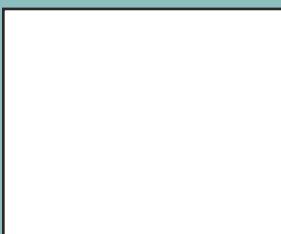
