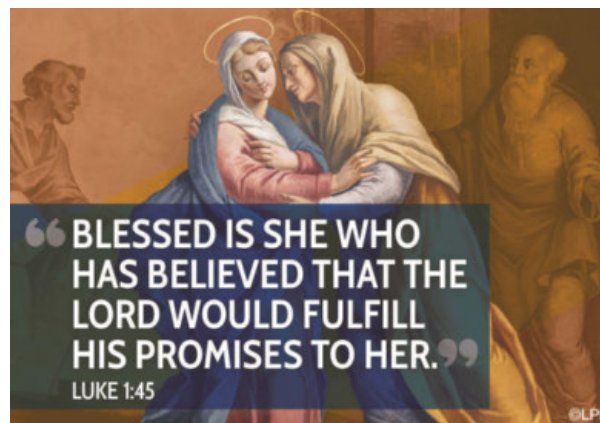
ST. MARY AND ST. AUGUSTIN PARISH COUNCIL

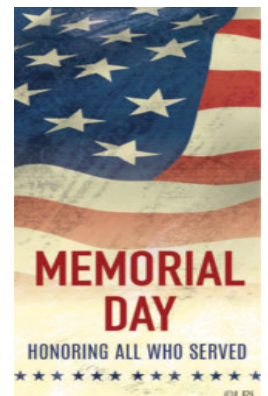
COMMUNITY FOOD PROGRAM

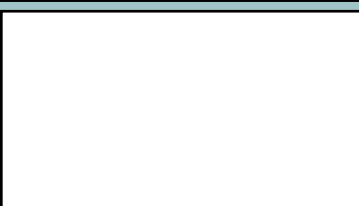
