

#### FROM THE DESK OF FR. MARK SAURIOL

Greetings Parishioners and a warm welcome to our Visitors,

This year, the Diocese of Providence marks its 150th anniversary (1872-2022) and all parishes join in the celebration. Those of you who are subscribers to our diocesan weekly newspaper, the *Rhode Island Catholic*, have received in the mail the 36-page issue of June 23, which commemorates this landmark occasion. The paper is chock-full of interesting articles and historical photos. You can obtain a copy for just \$1 plus postage by phoning Sue Richard at the R.I. Catholic at (401) 621-5959. She'll include an invoice in the envelope and you can send in a check after you receive the paper. If you are interested in a subscription, Sue can help with that as well (\$30 per year).

While many parishioners are aware that St. Mary's parish is older than the Diocese of Providence, itself, they may be surprised to know that we have been a part of three different dioceses over the years. When established in 1828, our parish, Rhode Island's oldest, was under the auspices of the Bishop of Boston, Benedict Joseph Fenwick. The Diocese of Boston, which covered all of New England, was split in 1843, and Rhode Island and Connecticut parishes became part of the newly established Diocese of Hartford, Connecticut. Rhode Island finally had its own diocese when the Diocese of Provi-

dence was established Feb. 16, 1872. Sister parish, Saint Augustin's was established in 1911. You'll learn more interesting historical information about the history of our diocese, including an update on renovation work at the 133-year old Cathedral of SS. Peter and Paul, designed by Irish-born architect, Patrick C. Keely, as was our St. Mary's Church, in the special issue of the *Rhode Island Catholic*. Enjoy!

May our Lord continue to bestow many blessings on the Diocese of Providence and our parishes in the years ahead.
