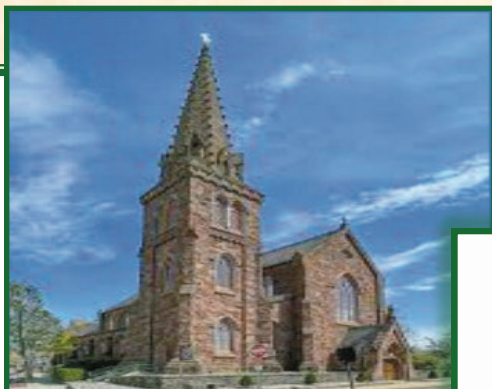
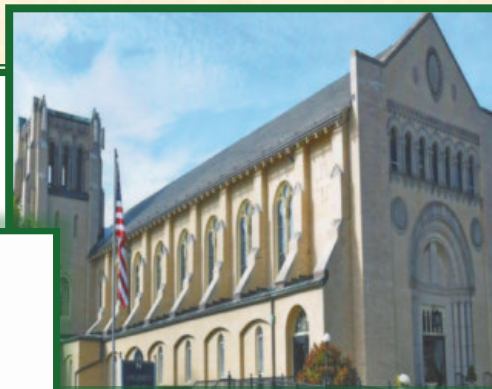

FROM THE DESK OF FR. MARK SAURIOL

Dear Parishioners,

You may recall the announcement in the bulletin a couple weeks back in which we shared that St. Augustin's parish had reached and exceeded its 2022 Catholic Charity Appeal goal of \$44,650. *Congratulations*, again, the people of St. Augustin's.

St. Mary's parish is significantly larger in terms of the number of registered families, so the Diocese assigns St. Mary's a much higher, but still achievable goal. I'm pleased to share that St. Mary's parishioners have contributed a total of \$81,728 towards the goal of \$97,850, so we are still shy about \$16,000. One hundred seventy five gifts have been made, which suggests that only about 15% of our registered families have made a gift of any size to the Appeal. While these are hard times for many, in my short time with you, I've seen what St. Mary's parishioners can achieve if they come together, and I believe we can still achieve the Appeal goal if everyone, *who is in a position to do so*, contributes just a bit.

Here is how St. Mary's can reach our goal: 200 families who have not yet given donate just \$5, 200 give \$10, another 200 give \$25, and 200 make a one-time gift to the appeal of \$50. That would raise \$18,000 and, most importantly, it would drive participation from 15% to 80%. That would be remarkable and something we could all be proud of! To make a gift, please make your check out to "Catholic Charity Appeal" and write "St. Mary's Newport" in the memo line, place in a separate envelope, and drop in the collection basket at Mass or mail to the parish office. Cash is gratefully accepted as well, but please be sure to mark the donation so we know it's from the appeal. You can also make a gift online by visiting the "Giving" page at DioceseofProvidence.org. Your gift, *in any amount*, WILL make a difference, and will support the important works of Christian charity by our Diocese, in Newport County, and throughout Rhode Island.

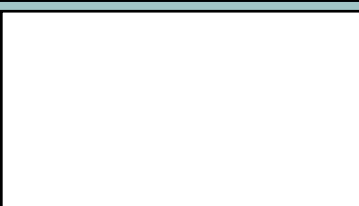
