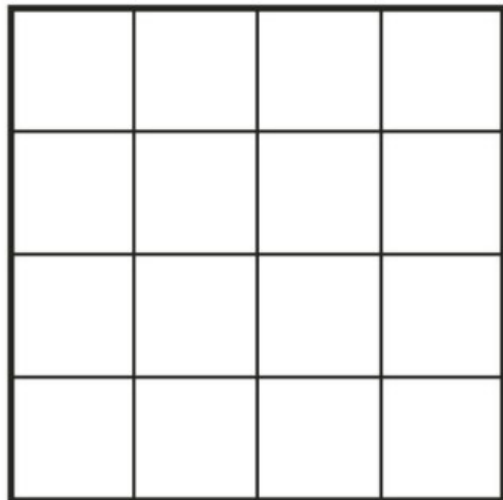

The Diocese of Providence invites couples who are celebrating their 25th, 40th, 50th or Over 50th wedding anniversary in 2022 to attend a Wedding Anniversary Celebration at the Cathedral of SS. Peter and Paul in Providence on Sunday Oct. 16 at 1pm.

The celebration includes Mass, renewal of wedding vows, a personalized certificate, and a reception for you and your guests. Bishop Thomas J. Tobin will be the main celebrant.

Advance registration is required, and the completed registration form must be submitted to the parish office and signed by Fr. Mark. The parish will then forward the form to the Diocese of Providence.

For your names to be published in the Mass booklet, the diocese must receive the completed, signed registration form by September 16.

Important: At least one spouse must be Catholic, with the marriage recognized by the Church. The celebration is for couples; if it is not possible for you both to be present, the certificate will be mailed to you.
