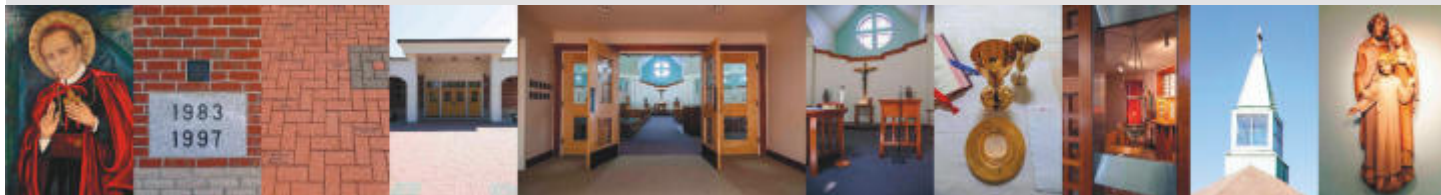

ALWAYS, EVERYWHERE, AND BY ALL

"Keep my commands and you will live; guard my teachings as the apple of your eye." —Prov 7:2

In his Commonitorium (ca. 434), St Vincent of Lerins (d. 445) explains the general rule whereby we distinguish Catholic truth from heresy. St Vincent was described by others as a man "preeminent in eloquence and learning". *The rule, in brief, is the authority of Holy Scripture.* Unfortunately, men differ in its interpretation. And the rule, in consequence, must be supplemented by an appeal to the sense of Holy Scripture which is supported by *universality, antiquity, and consent.* By *universality*, when it is the faith of the whole Church; by *antiquity*, when it is that which has been held from the earliest times; and by *consent*, when it has been the acknowledged belief of all, or almost all, whose office/character gave authority to their determinations.

Saint Lerins' famous axiom was *Quod ubique, quod semper, quod ab omnibus* [Lt., "what (has been held) always, everywhere, by everybody"]. This is the first time the we find the axiom that for a dogma to be considered as Catholic truth it must have been held always, everywhere, and by all the faithful. The following are excerpts from the Commonitorium 4-6, and 73. Italics added.

4. I HAVE often then inquired earnestly and attentively of very many men eminent for sanctity and learning, how and by what sure and so to speak



universal rule I may be able to distinguish the truth of Catholic faith from the falsehood of heretical pravity; and I have always, and in almost every instance, received an answer to this effect: That whether I or any one else should wish to detect the frauds and avoid the snares of heretics as they rise, and to continue sound and complete in the Catholic faith, we must, the Lord helping, fortify our own belief in two ways; *first, by the authority of the Divine Law, and then, by the Tradition of the Catholic Church.*

5. But here some one perhaps will ask, Since the canon of Scripture is complete, and sufficient of itself for everything, and more than sufficient, what need is there to join with it the authority of the Church's interpretation? For this reason, —because, owing to the depth of Holy Scripture, all do not accept it in one and the same sense, but one understands its words in one way, another in another; so that it seems to be capable of as many interpretations as there are interpreters. For Novatian expounds it one way, Sabellius another, Donatus another, Arius, Eunomius, Macedonius, another, Photinus, Apollinaris, Priscillian, another, Iovinian, Pelagius, Celestius, another, lastly, Nestorius another. Therefore, it is very necessary, on account of so great intricacies of such various error, that the rule for the right understanding of the prophets and apostles should be framed in accordance with the standard of Ecclesiastical and Catholic interpretation.
6. Moreover, *in the Catholic Church itself, all possible care must be taken, that we hold that faith which has been believed everywhere, always, by all.* For that is truly and in the strictest sense "Catholic," which, as the name itself and the reason of the thing declare, comprehends all universally. *This rule we shall observe if we follow universality, antiquity, consent.* We shall follow *universality* if we confess that one faith to be true, which the whole Church throughout the world confesses; *antiquity*, if we in no wise depart from those interpretations which it is manifest were notoriously held by our holy ancestors and fathers; *consent*, in like manner, if in antiquity itself we adhere to the consentient definitions and determinations of all, or at the least of almost all priests and doctors.
73. [See 1 Cor 12:27-28] Lest anyone perchance should rashly think the holy and Catholic consent of these blessed Fathers to be despised, the Apostle says in the First Epistle to the Corinthians, "God hath placed some in the Church, first Apostles," of whom himself was one; "secondly Prophets," such as Agabus of whom we read in the Acts of the Apostles; "then doctors," who are now called homilists, expositors, whom the same Apostle sometimes also calls "prophets," because by them, the mysteries of the prophets are revealed to the people. Whosoever therefore shall despise these who had their appointment of God in the Church in their several times and places, when they are unanimous in Christ

in their interpretation of some point of Catholic doctrine, despises not man, but God ... if anyone should dissent from their unanimous decision, let him listen to the words of the apostle: "God is not the God of dissension, but of peace."

By way of example, the excerpts below are from Pope Pius XI's 10 Mar 1937 encyclical Mit Brennender Sorge [Lt., With Deep Anxiety] which condemned breaches of the 1933 concordat agreement signed between the Holy See and the German Reich.

8. WHOEVER exalts race, or the people, or the State, or a particular form of State, or the depositories of power, or any other fundamental value of the human community —however necessary and honorable be their function in worldly things—whoever raises these notions above their standard value and divinizes them to an idolatrous level, distorts and perverts an order of the world planned and created by God; he is far from the true faith in God and from the concept of life which that faith upholds.
16. Whoever wishes to see banished from church and school the Biblical history and the wise doctrines of the Old Testament, blasphemes the name of God, blasphemes the Almighty's plan of salvation, and makes limited and narrow human thought the judge of God's designs over the history of the world: he denies his faith in the true Christ, such as He appeared in the flesh, the Christ who took His human nature from a people that was to crucify Him; and he understands nothing of that universal tragedy of the Son of God who to His torturer's sacrilege opposed the divine and priestly sacrifice of His redeeming death, and made the new alliance the goal of the old alliance, its realization and its crown.
17. The peak of the revelation as reached in the Gospel of Christ is final and permanent. It knows no retouches by human hand; it admits no substitutes or arbitrary alternatives such as certain leaders pretend to draw from the so-called myth of race and blood. Since Christ, the Lord's Anointed, finished the task of Redemption, and by breaking up the reign of sin deserved for us the grace of being the children God, since that day no other name under heaven has been given to men, whereby we must be saved (Acts iv. 12). No man, were every science, power and worldly strength incarnated in him, can lay any other foundation but that which is laid: which is Christ Jesus (1 Cor. iii 11). Should any man

dare, in sacrilegious disregard of the essential differences between God and His creature, between the God-man and the children of man, to place a mortal, were he the greatest of all times, by the side of, or over, or against, Christ, he would deserve to be called prophet of nothingness, to whom the terrifying words of Scripture would be applicable: "He that dwelleth in heaven shall laugh at them" (Psalms ii. 3).
