My dear brothers and sisters, as I am writing this page, the result of the election is still being decided. We certainly live in unprecedented times, requiring each of us to go back to the roots of Christianity and to its authenticity. Another sign of the times; in our state,

Proposition 115 did not pass, thus indicating that at least 60% - though some may have not understood the implications of what they were opposing- of the people in our state are in favor of killing a baby up to the point of birth, gives us a sense of the society in which we are living. I invite all of us to pray for our Church, that the Church may continue to remain faithful to the mandate of Christ! Each of us needs to do our part in renewing our spirit to a deeper encounter with Christ.

Finally, some have asked about the Holy Fathers words concerning homosexual civil unions recently reported in a documentary. The Vatican Secretary of State has issued a clarification and I am copying some parts from a CNA article regarding that issue: "the Vatican's Secretary of State has asked papal representatives to share with bishops some clarifications regarding comments on civil unions made by Pope Francis in a recently released documentary, according to the apostolic nuncio to Mexico, His Excellency Coppolo. The clarifications explain that the Pope's comments do not pertain to Catholic doctrine regarding the nature of marriage as a union between one man and one woman but, to provisions of civil law.[...] The post explained that in a 2019 interview, unpublished parts of which were aired in the recent documentary, the Pope commented at different times on two distinct issues: that children should not be ostracized from their families because of their sexual orientation and on civil unions,

amid discussions of a 2010 same-sex marriage bill in the Argentine legislature, which Pope Francis, who was then the Archbishop of Buenos Aires, opposed. The interview question that prompted remark on civil unions was “inherent in a local law from ten years ago in Argentina on “equal marriage of same sex couples” and the opposition of then Archbishop of Buenos Aires, in this regard. In this regard, Pope Francis has affirmed that “it is an incongruity to speak of homosexual marriage” adding that, in the same context, he had spoken of the right of these people to have certain legal coverage: “what we have to do is a law of civil union; they have a right to be covered legally. I defended that.” Moreover, it is important to make present that “the Holy Father had expressed himself thus during an interview in 2014: “Marriage is between a man and a woman. The secular States want to justify civil unions to regulate various situations of coexistence, moved by the demand to regulate economic aspects between people, such as securing health care. These are coexistence pacts of a different nature, of which I would not be able to give a list of the different forms. It is necessary to see the various cases and evaluate them in their variety,” the post added. Therefore it is evident that Pope Francis has referred to certain state provisions, certainly not to the doctrine of the Church, reaffirmed numerous time over the years. (Excerpts from CAN)

Having myself listened to the original interview in Spanish, I can assure you that, as we have witnessed more and more on media and news outlets, the manipulation of one’s thought and words is indeed becoming the norm of these times. Let us keep our Church and our society in our prayers.

Religious Education

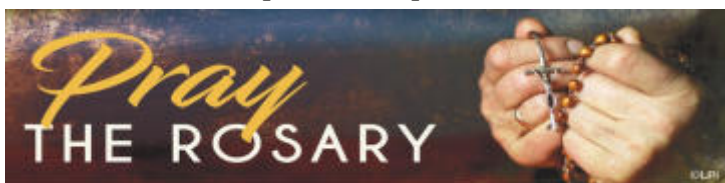

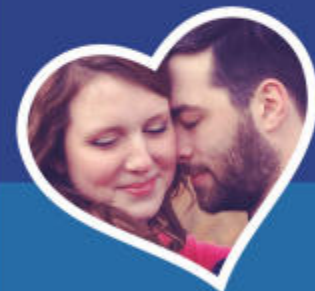
