THE SACRAMENT OF PENANCE AND RECONCILIATION



Jesus calls to conversion. This call is an essential part of the proclamation of the kingdom: "The time is fulfilled, and the kingdom of God is at hand; repent, and believe in the gospel."

It is called the sacrament of conversion because it makes sacramentally present Jesus' call to conversion, the first step in returning to

the Father from whom one has strayed by sin.

It is called the sacrament of Penance, since it consecrates the Christian sinner's personal and ecclesial steps of conversion, penance, and satisfaction.

It is called the sacrament of confession, since the disclosure or confession of sins to a priest is an essential element of this sacrament. In a profound sense it is also a "*confession*" - acknowledgment and praise - of the holiness of God and of his mercy toward sinful man. It is called the sacrament of forgiveness, since by the priest's sacramental absolution God grants the penitent "*pardon and peace*."

It is called the sacrament of Reconciliation, because it imparts to the sinner the love of God who reconciles: "*Be reconciled to God*." He who lives by God's merciful love is ready to respond to the Lord's call: "Go; first be reconciled to your brother." (From CCC 1423, 1424 & 1427)

As we have the Lenten penance service in our church on Wednesday, April 2nd 2025, I would like to invite all of you to make a good confession and be renewed in body and spirit.

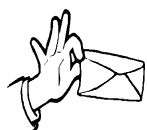
