**"BAPTISM"**

Once the necessary promises have been made by either the candidate themselves or the parents and godparents, the ritual of Sacramental Baptism continues with the participants listening to the Word of God. Our Catholic faith is based upon the revelation God has given to us in Sacred Scripture and in Sacred Tradition. God has revealed to us in both the Old and New Testament, His immense love for us and His desire for us to be with Him for all eternity. God longs to share with us the eternal life forfeited by Adam and Eve in the Garden of Eden when they were beguiled by Satan and doubted God's love for them.

Listening to God's Word is important for us throughout our lives. We need to develop the good practice of taking time to listen to God, to seek to comprehend the true meaning of God's love for us as individuals of the human race. The minister of the Sacrament will often take a few minutes to thank the candidate or the parents and godparents for promising to this community of faith and to God, that they will raise the child in the practice of the faith and help them to understand God's love for them. The community also pledges to assist the family in this task of education. Parishes sponsor Christian Formation Programs to help families to share the faith with the young people. However, the Christian Formation sessions are not meant to be a substitute for the instruction and training the child can receive at home where there is daily exposure to God, His divine Word and the application of Christian ideas to the daily lived experience.

Following the brief homily the first anointing takes place. This anointing, called an exorcism, is an anointing for strengthening against evil. The oil which is used is called the "Oil of the Catechumen". It was blessed by the local bishop, in our case Bishop LaValley, at the Chrism Mass just before Holy Week. It is then distributed along with the "Chrism Oil" and the "Oil of the Sick" to the parishes for use in the celebration of the various sacraments. The prayer of strengthening is prayed over the candidate for baptism and then the person is anointed on the chest with the Sign of the Cross, using the holy oil. Thus strengthened by God's Spirit the candidate is then prayed for by the Church militant and the Church Triumphant, the Church on earth and the Church in heaven. We sing the Litany of Saints asking the Saints of God to intercede on our behalf to almighty God on behalf of this candidate who is about to receive the grace of Baptism. The Litany can be very moving and powerful when we take time to actually think that all these people, who are glorified in heaven and living the presence of God, are asking God to pour out His grace upon this candidate.
