





Diocesan Bankruptcy Proceedings

Dear Friends,

As some of you have already heard from me before Mass last week, on Thursday, October 1st, our Diocese, the Diocese of Rockville Centre, filed for Chapter 11 Bankruptcy in U.S. Bankruptcy Court. This is sad news, but necessary as over 200 lawsuits have been filed against the Diocese under the New York State Victims Act which rolled back the statute of limitations for claims.

Many of you may be wondering how this bankruptcy filing affects us here at St. Sylvester — in short, it doesn't. We are an independent entity in the State of New York, separate from the Diocese. ***We are not filing for bankruptcy!*** Our daily operations, as well as the celebration of the sacraments and the continuation of regular parish life, will be unaffected by the actions of the Diocese.

The Diocese will continue to administer health and welfare benefits to our staff, along with the various retiree programs, without interruption. The funds for these programs are held in trust and can only be used for their specified recipients.

Please be assured that any settlement will be solely determined based on the assets of the Diocese and *will not include* any parish offertory donations collected during Mass or mailed in, nor any contributions to the Catholic Ministries Appeal. **Parish collection income will be used only for activities here at St. Sylvester.** Again, monies from the offertory collection *will not* be used to settle claims. I have included a Q & A on the following pages which will hopefully answer any remaining questions or concerns that you may have.

This action by the Diocese has the goal of completing a settlement that includes a comprehensive and final resolution for suffering survivors. Let us pray first and foremost for the victims and secondly for the Diocese.

Questions and Answers Regarding the Diocese Filing

General Q&A

1. What is Chapter 11?

Chapter 11 is a legal mechanism for court-supervised reorganization or restructuring of a corporation's obligations. Chapter 11 provides a way for a corporation to address its financial condition in order to remain a viable entity, while continuing day-to-day operations.

2. Why did the Diocese of Rockville Centre (The Diocese) file for Chapter 11?

The Diocese took this action to ensure the viability of its ongoing mission and charitable services, while it works toward a fair and equitable way to compensate survivors of sexual abuse who brought lawsuits under the Child Victims Act. Ensuring fair and equitable settlements with all survivors requires the Diocese to manage the increasing costs of this litigation. Filing will allow the Diocese to work toward a settlement with survivors AND, at the same time, maintain its mission; serving the common good of all.

3. What entities are included in the Chapter 11 filing?

Only the Diocese itself is included in the filing. Parishes, Catholic schools and religious orders within the Diocese are not included in the filing. The Diocese of Rockville Centre is a distinct religious corporation from the Parishes, some of which include Catholic Schools as part of their missions. Some of the Parishes are named in Child Victims Act lawsuits along with the Diocese. The Diocese will ask the Bankruptcy Court to “stay,” or halt, any civil actions against the Parishes and bring these cases under the umbrella of the process to resolve abuse lawsuits that they expect to set up in the Chapter 11 case.

4. How does the Chapter 11 filing impact DRVC Schools?

Parishes, elementary schools and high schools are separate legal entities from the Diocese and are not filing Chapter 11. The Chapter 11 filing is not expected to have a direct impact on the day-to-day operations of our schools or parishes. The continued employment, salaries, and benefits of DRVC school employees also will not be impacted by this filing.

5. Why choose bankruptcy?

We hope this choice will establish a single process to compensate all survivors. We believe this offers the best opportunity for equitable settlements for all survivors.

6. Why now?

The Diocese has been named in more than 200 lawsuits since the Child Victims Act went into effect August 14, 2019. It has become clear to the Diocese that, to ensure that available financial resources are distributed fairly, it must mitigate the increasing litigation expenses and implement a comprehensive and equitable settlement with all survivors.

7. Is the bankruptcy a way to minimize your financial responsibilities to the victims?

No. The bankruptcy process will provide a transparent look at the Diocese's financial status. All documents filed in a Chapter 11 are available publicly, including information about financial resources, borrowing, insurance coverage, investments, pension obligations and expenses. It will be plain to see what the Diocese can afford to pay survivors. Our goal is to compensate the survivors of abuse as equitably as possible while continuing with our charitable missions. ~ continued on next page

8. What happens to the lawsuits that have been filed against the Diocese?

The Chapter 11 filing triggers a "stay" that essentially freezes all litigation against the Diocese. The Diocese will work with all survivors, within the Chapter 11 process, to finalize a settlement of the litigation claims. The claims and settlement will be part of the Diocese's Plan of Reorganization and must be approved by the Court before the Diocese can emerge from bankruptcy.

9. Does the Diocese have enough money to continue operating?

The Diocese believes its current and future liquidity will be sufficient to fund normal operations and services during the restructuring process and beyond. Vendors will be paid for all goods and services after the filing, and transactions that occur in the ordinary course of business will continue as before. Employees will be paid their normal wages, and health and benefits programs will continue uninterrupted.

10. How long will the Diocese be in Chapter 11?

The Diocese of Rockville Centre will work to emerge from Chapter 11 as soon as possible. Given the seriousness of this situation, and the importance of dealing fairly with the survivors of abuse, we cannot give a definitive end date at this time.

11. Have other Dioceses filed and come out of Chapter 11?

Yes. Since the Child Victims Act was enacted and the window opened on August 14, 2019, four of the eight dioceses in New York have filed Chapter 11. While the New York Dioceses are still in the reorganization process, many other dioceses across the country have, through the Chapter 11 process, reached settlements with survivors of abuse.

12. Will my gift/donation to the Catholic Ministries Appeal or other specific funds to be used to pay legal settlements?

No. Gifts and donations that are made to the Catholic Ministries Appeal or to support specific ministries and programs will only be used for those purposes. Designated gifts can only be used for the purposes for which they were and are given.

13. Where did the Diocese file?

The petitions were filed in U.S. Bankruptcy Court for the Southern District of New York.

14. Where can I find Chapter 11 case information?

To ensure access to all restructuring information, the Diocese of Rockville Centre has created a link to its Reorganization Information page on the diocesan website, www.drvc.org, which contains a variety of information on our Chapter 11 restructuring. The Diocese has also set up a toll-free information line for inquiries at (888) 490-0633. Parish Q&A

15. Is our Parish included in the DRVC Chapter 11 filing?

No. Our Parish is a separate legal entity and therefore not included in the Chapter 11 filing of the Diocese.

16. Will our Parish file bankruptcy too now that the Diocese has filed?

No. There are no plans for parishes to file for Chapter 11.

17. What if our Parish has been named in a sexual abuse lawsuit? Will we need to file for bankruptcy to resolve it?

The Diocese will ask the Bankruptcy Court to “stay” or halt any sexual abuse actions against parishes and bring these cases under the umbrella of the process in order to resolve them.

18. Will my donation to the Parish during Mass now be used to settle sexual abuse lawsuits?

No. Monies collected from donors and parishioners will not be redirected toward litigation settlements.

19. What effect will the filing have on the operations and stability of Elementary and High Schools?

Each school is a separate legal entity from the Diocese and is also not included in the bankruptcy filing.

Schools continue to pursue a variety of initiatives aimed at stabilizing and revitalizing. Today’s Chapter 11 filing, and the related legal proceedings, will not have direct impact on their day-to-day operations. The continued employment, salaries, and benefits of school employees will not be impacted by this filing.

20. Is there a chance that money for the DRVC schools could be used to pay abuse settlements?

Tuition, philanthropic support, and parish support of schools will, as always, be fully dedicated to funding the operations of the schools and are not impacted by the Diocese’s Chapter 11 filing.

21. If a parishioner has made a designated gift or donation to this parish, will that money remain here, or can it be moved to the Diocese for settlement purposes?

Designated gifts and donations are protected under New York state law and cannot be used to settle claims.

22. Will the Diocese lay off any employees as a result of the restructuring?

The Diocese has already made extensive budget cuts that resulted in the reduction of approximately ten percent of its workforce. At this time, no additional layoffs are expected.

23. The Diocese administers the lay and clergy pension and 403B funds, along with health and welfare benefits for parishes. Will there be changes in these programs? Will these funds be available to use for settlements?

The Diocese serves only as the administrator of these funds. The actual funds are held in trusts that are not available to any party for reasons other than the payments to beneficiaries as laid out in the various programs. We expect no changes in these programs as a result of the Diocese's filing.

24. Is there a chance that the Diocese will sell this Parish or other real estate to help settle claims?

No. This parish and any real estate surrounding it are property of this parish, which is a separate legal entity from the Diocese. The Diocese does not have a legal right to sell property that belongs to a parish corporation.

25. If our parish has been the subject of a sexual abuse allegation or lawsuit, what impact does the Diocese's filing have?

The bankruptcy process should bring closure to the lawsuits facing the Diocese and a release for all parishes from any and all abuse claims. As we move through the settlement process, additional information will be available.

PARISH INFORMATION

As we continue to navigate through this challenging time, we are pleased to be able to say that things are beginning to open up here at the parish, although in a limited way. We are happy to communicate the following:

WEEKEND MASSES ARE CELEBRATED AT 5PM ON SATURDAYS AND 9AM AND 11AM ON SUNDAYS. You must register to attend these Masses weekly through our parish website beginning each Wednesday morning at 9am. The program will stop accepting reservations on Friday at 3pm (or sooner if it reaches a maximum of 80 people for that particular Mass). Ushers will check your registrations at the door before entering the church and will seat you. The pews in the church are marked off to maintain social distancing.

WEEKEND MASSES WILL NOW BE LIVE STREAMED ON YOUTUBE AT 5PM AND 11AM —LINK AVAILABLE FROM OUR WEBSITE. If you click on the Mass and it has already begun, you will have the ability on *YouTube* to rewind the Mass to the beginning while it is in progress. Don't worry if you are unable to rewind — the Mass in its entirety will also be available immediately after its conclusion. Live streaming will allow you to attend Mass at home simultaneously with your fellow parishioners in the church, and with much clearer video and sound than we have been able to offer in the past.

THE SACRAMENT OF RECONCILIATION IS OFFERED ON SATURDAYS AT 4PM IN THE CHURCH. Unfortunately due to limited seating, you cannot remain for the 5pm Mass after Reconciliation if you have not reserved a seat ahead of time.

WEEKDAY MORNING MASSES ARE CELEBRATED ON MONDAYS, TUESDAYS, THURSDAYS AND FRIDAYS AT 8:30AM IN THE CHURCH. You do not need to register for these Masses.

THE PARISH OFFICE IS NOW OPEN ON MONDAYS, WEDNESDAYS AND FRIDAYS FROM 9AM TO 12PM TO ASSIST YOU WITH MASS CARDS, ANNOUNCED MASSES, MEMORIALS, SACRAMENT CERTIFICATES, ETC.

As we continue to navigate the public celebration of Mass within State Guidelines, St. Sylvester Parish will offer Mass on Saturdays at 5PM and Sundays at 9AM & 11AM.

Please note the following important information:

- **At this time, the bishop still dispenses all the faithful from the obligation to attend Sunday Mass and Holy Days of Obligation.**
- **Our Sunday worship will continue to be posted on the website for those who are vulnerable, for those who have a health impairment that would make them more susceptible to serious illness, for those who might not be feeling well, or have a fever, and for those who are caretakers for other people who are vulnerable. If you are in any of these situations, you are encouraged to continue to remain at home and worship online.**
- **Restrooms will be open for emergency use only! Please use bathroom at home!**
- **There is a mandatory online reservation system for all who wish to attend Mass. Please register beginning Wednesdays at 9am by going to www.stsylvesterli.org**
- **Please print out your registration information or have available on your phone as you will be asked to show your registration before entering the church.**
- **Masks or other face coverings must be worn by all participants.**
- **Please arrive 15 minutes before Mass so your reservation may be confirmed and you may be shown to your seat. Capacity at this time is limited to 25%.**
- **Seating will be done according to social distancing guidelines. You will most likely not be sitting in your “usual” seat. Families may sit together at Mass. There is no “saving seats” or asking to be seated in a particular seat.**
- **The Offertory procession and passing of the donation basket will be omitted.**
- **If you wish to make a contribution, there will be baskets at the entrance and exit. Contributions may also dropped at the parish center or made online.**
- **The Sign of Peace or other greetings will not be exchanged.**
- **Directions will be given for Communion, which will be distributed after Mass as you are leaving the church. Please follow the directions of the ushers.**
- **No bulletins will be distributed. Please read the bulletin online.**
- **Please go directly to your car, as no congregating is permitted.**
- **We will continue to keep you updated on changes as we move forward.**

This is a work in progress, so as we move forward there may be changes. We appreciate your patience and want you to know that our first priority is that those attending Mass will be safe.

Revised & Simplified Faith Formation Program 2020-2021 !

Dear Parents/Guardians and Catechists,

We have revised and simplified the St. Sylvester Faith Formation Program so that it will be **more manageable and yet still meaningful** for all involved, Catechists, students, and their families.

As school districts are moving forward with plans for the school year, it has become clear to us that parents and students may be challenged by the newness of what lies ahead. This combined with parents changing work situations has caused us to take another look at the Faith Formation Program we are offering and how we can be more accommodating to all.

If you have already registered your child, we hope this will make life a little easier. If you have not yet registered your child, the hope here is that with this more accommodating schedule, you will now reconsider registering them.

Here is the revised and simplified Faith Formation Program for 2020-2021 Year for Levels 1 through 7!

- ♦ Arrangements will be made for a curbside pickup of the materials (books, calendar, etc.) needed for each of your children so they can work from home.
- ♦ There will be 4 virtual meetings on the Zoom platform, for the year, that we ask students to try their best to attend (with the help of a parent). So, for example, if you registered your child for a Level 5 class on Mondays at 4:30 p.m., your child's class will be held four (4) times virtually on 4 specific Mondays at 4:30 p.m. according to the Level 5 Calendar. If you registered your child for Level 3, 4 or 5 Home Taught the virtual; meetings will be held on Saturdays according to the Home Taught Level 3, 4 or 5 calendars. Level 1 will be Home Taught and have four (4) virtual meetings on specific Saturdays according to the Level 1 calendar.
- ♦ The calendar will not begin until Monday, November 30, 2020 to give everyone time to adjust to the school schedules, etc. and will end in May.
- ♦ Parents with children who have special needs!
Parents, for students who are in the Individualized Faith Formation Program or whose needs would make it difficult to stay focused virtually, we will work directly and individually with you to accommodate your child's needs. Please go ahead and register your child for the next Level in the Individualized Faith Formation Program. If you have questions, please email faithformation@stsylvesterli.org



Food for Thought

This weekend we hear St. Paul once again address the Philippians, *"I have learned the secret of being well fed and of going hungry, of living in abundance and of being in need. ...My God will fully supply whatever you need ..."*

We are, today, a nation consumed with being well fed. At any time of day, you can probably find a cooking show and a chef reality show on TV, or an infomercial touting the latest air fryer or copper pot. And yet, grand meals are not really necessary for our sustenance. St. Paul talks about having lived in abundance and also in need. Many who lived through the Great Depression speak about being poor and not having much to eat, and yet they thrived in spite of those difficult circumstances. Why? They had faith in someone bigger than Rachael Ray. They knew, like St. Paul tells us, that while times were tough, God would ultimately provide for them—giving them not necessarily all that they wanted, but filling their needs. Families and neighbors were spurred by their faith and humanity to join together; those who had a little more shared with others.

As Christians who live Stewardship daily, we know deep down that right now it is faith, forgiveness and compassion that we should be sharing, not simply Lysol or paper products. Times are tough right now for many, many families and we have a responsibility to help as much as we can, but what we need most of all is food for our souls. Our communities and our nation are deeply divided and hungry for Christ's peace.

Do we live our lives believing that God *"will fully supply whatever you (we) need"* or are we hedging our bets by insulating ourselves from others and withholding our God-given gifts of compassion, love, time, financial resources, etc.—just in case He doesn't come through for us in the end?

Jesus tells us today in Matthew's Gospel that *"The feast is ready..."* Are we ready to accept the invitation?
