



**Holy Redeemer School**  
**Indiana School Choice Program**  
**2021-2022 School Year**  
**Effective July 1, 2021**

Choice Scholarships provide State funding to qualifying students that can be used to offset tuition costs at participating Choice schools. Each individual student (not family) must qualify based on both (1.) Voucher Pathway and (2.) household income guidelines. If you have any questions, please do not hesitate to ask the school office for clarification or help.

### **1. Voucher Tracks**

The School Choice Scholarships are awarded for up to the full amount of tuition and fees per child through the State of Indiana. Students must meet one or more of the following tracks. If a student meets one of these criteria then you may proceed to part 2 (Income Guidelines) of the qualifications.

- **Previous Choice Scholarship Student Track** - Student received a Choice Scholarship in a previous school year.
- **Previous SGO Track** - Student received an SGO Scholarship in a previous school year from an approved scholarship granting organization.
- **Special Education Track** - Student has a disability that requires special education and has an individualized education program (IEP or SP). 504 Plans do not qualify under this pathway.
- **"F" Public School Track** - Student would be required to attend a specific public school based on their residence that has been assigned an "F" grade.
- **Two Semesters in Public School Track** - Student was enrolled in a public school in Indiana for the complete 20-21 school year.
- **Sibling Track** - Sibling of the applying student received either a Choice Scholarship Voucher or an SGO Scholarship in a previous year.

### **2. Income Guidelines**

Students that have met one of the above tracks may qualify for a Choice Scholarship if they meet the financial guidelines listed below. The Household Adjusted Gross Income is used to determine income eligibility. A student may be eligible for a "90% scholarship. This is not 90% Holy Redeemer's tuition, but 90% of what the public school is allocated by the state of Indiana per student if the student attended their public school. (EVSC's student rate was \$6,617.90 for the 2020-2021 school year. Please refer to the back of this page to see an example. )

### **Tuition Costs for "90%" Scholarship**

Tuition amounts may vary depending on number of children enrolled at Holy Redeemer School, being an active parishioner at Holy Redeemer Church, or a non-parishioner. \*\*These costs are based upon EVSC figures from 2020-2021.

The charts on the second page are the breakdown of tuition costs for the 2021-2022 school year at Holy Redeemer School **if your child meets one of the pathways and meets the financial requirements.** (The amounts are based off of the EVSC school district rates. Other school districts will vary slightly.)

**Tax Credit Scholarship (SGO)** The Tax Credit Scholarship (SGO) from the Institute for Quality Education (KG-8) is a \$500 minimum award from Educational CHOICE Charitable Trust. The legislation allows for all current Holy Redeemer students, new and eligible incoming students, including kindergarten, to apply. This is a "stepping stone pathway" scholarship for students to become eligible for the School Choice Scholarship if financial requirements are met for the School Choice Scholarship the following year. All SGO scholarship money is donated by Holy Redeemer Parishioners and the Knights of Columbus. The Tax Credit Scholarship is limited and will be awarded based only on availability of funds. Families are encouraged to consider making a donation to the SGO. That donation will result in a 50% tax credit for the donor and will support the growth of Holy Redeemer School.
