## TUITION ASSISTANCE FOR 2021/2022 SCHOOL YEAR

The Catholic Education Foundation, the Archdiocese of Louisville and the funding partners are helping more families than ever who cannot afford the full cost of educating their children in a Catholic elementary school. All families with one or more children enrolled in or applying to a Catholic elementary school may apply.

Tuition assistance applications should be submitted between **December 15, 2020 and February 28, 2021**. A single form, the FACTS management application, will be used for all forms of Catholic elementary school tuition assistance. Families must use the online application on our website, [www.ceflou.org](http://www.ceflou.org).

To make the application process easier for families, you will submit your **2019** federal income tax return and **2019** W-2 information.

You must reapply for tuition assistance every year. Award letters will be mailed to families no later than June 15, 2021.

### GROW AS A DISCIPLE

PRAY, STUDY, ENGAGE, SERVE

During Advent, we await the One who is perfect grace, light, and joy. The Christ Child's arrival during a time when darkness has been increasing each day, and our anticipation of that arrival, emphasize his salvific role. For if even the smallest light is a glimmer of hope in the night, how much more is Christ's perfect and all-consuming light a life-saving flare in the darkness of sin and death. As we hear the angel Gabriel say of Christ, in his visitation to Mary: "He will be great and will be called Son of the Most High ... and of his kingdom there will be no end." Emmanuel, God with us, is the reason for our hope, and the reason for our joy.

### GO EVANGELIZE

PRAYER, INVITATION, WITNESS, ACCOMPANIMENT

I don't know about you, but despite my best intentions, I have been known to get a little swallowed up in the commercialism of Christmas. But this last week of Advent feels like a chance to reorder my mind and heart. One way to do this is by focusing on the "O Antiphons," prayed during the Church's evening prayer from December 17-23. Each antiphon begins with the word "O," and is followed by a title for the Messiah, found in Scripture, and a petition for him to come and save his people. Although this may sound overly complicated, you most likely know of these without realizing it: they have been transposed into the verses of the hymn, *O Come, O Come, Emmanuel*. Today's first reading speaks of David, who thought he could build a place for God to dwell, but he can't. Instead, for us, whom God created and fashioned in his own image, God created a dwelling for his Son, so that he might enter into our human history as one of us; and in doing so, dwell among us and within us forever. Come, Lord Jesus.

### INVITE

When lighting the final candle on your Advent wreath, invite your family to help you make the prayer interactive. Focus on the lesser-known verses of *O Come, O Come, Emmanuel*, such as the one below - it is an ancient prayer still very relevant today.

*O King of the Nations*

O come, Desire of nations, bind  
In one the hearts of humankind;  
O bid our sad divisions cease,  
And be for us our King of Peace.

*Rejoice! Rejoice! Emmanuel  
shall come to you, O Israel.*

## What the **CARES Act** means for your charitable giving?



The purpose of the Coronavirus Aid, Relief and Economic Security (CARES) Act is to help combat the far-reaching impacts of COVID-19. The bill provides increased tax incentives for charitable giving for both individuals and corporations to stimulate philanthropy throughout America.

### **Are you itemizing deductions?**

The adjusted gross income (AGI) limit for cash contributions was increased for individual donors. For cash contributions made in 2020, you can now elect to deduct up to 100% of your AGI (increased from 60%).

### **Interested in corporate giving?**

The AGI limit for cash contributions was also increased for corporate donors. Corporations can now deduct up to 25% of taxable income (increased from 10%).

### **Not itemizing?**

The CARES Act allows for an additional, “above-the-line” deduction for charitable gifts made in cash of up to \$300. If you are not itemizing on your 2020 taxes, you can claim this new deduction.

### **Wondering about your Giving Account?**

Both of these new incentives apply only to cash contributions to public charities and do not apply to contributions to supporting organizations or public charities that sponsor donor-advised funds. However, there have been no changes to existing deductions for contributions made into a donor-advised fund like your [Giving Account](#). This means you are still able to deduct up to 60 % AGI in cash and up to 30% AGI in appreciated assets contributed to a donor-advised fund.

Existing carry-over rules still apply, so if your donations in 2020 exceed your AGI deduction limits, you may carry forward excess deductions for up to five subsequent tax years. As always, donors should consult with their tax and legal advisors when considering their charitable giving.

### **What about IRA Qualified Charitable Distributions (QCD)?**

The CARES Act did not change the rules around the [QCD](#), which allows individuals over 70½ years old to donate up to \$100,000 in IRA assets directly to charity<sup>1</sup> annually, without taking the distribution into taxable income. However, under the CARES Act an individual can elect to deduct 100% of their AGI for cash charitable contributions. This effectively affords individuals over 59½ years old the benefits similar to a QCD; they can take a cash distribution from their IRA, contribute the cash to charity, and may completely offset tax attributable to the distribution by taking a charitable deduction in an amount up to 100% of their AGI for the tax year.

If you're planning a large donation in 2020, this may be a smart strategy as long as you are between the ages of 59½ and 70½ and are not dependent on existing retirement funds.

## St. Bernard Catholic Church

The CARES (Coronavirus Aid, Relief and Economic Security) ACT includes provisions to incentivize individuals and corporations to make cash contributions to public charities in 2020.

**Above-the-line deduction.** Under prior IRS rules, if you do not typically itemize your deductions on your income tax return, you are not permitted to take a charitable deduction for cash contributions to qualified charities. The CARES ACT, however, temporarily suspends this limitation. But only for the 2020 tax year. The CARES ACT has added a new above the line \$300 deduction for cash contributions to a qualified charity like St. Bernard. At a minimum, therefore, why not consider making a gift this year of at least \$300 to St. Bernard? The gift would be beneficial to you and to the parish.

**Relaxed limitations on deductions for individuals.** A second benefit of the CARES ACT is for those who DO itemize deductions. The CARES ACT increases the allowable deduction for cash contributions to a qualified charity like St. Bernard to **100% of your adjusted gross income**. This, too, however, is for the **tax year 2020 only**. For example, if your charitable donation in 2020 to St. Bernard matched your AGI (adjusted gross income) dollar for dollar, you would have no taxable income in 2020. Additionally, if your contribution in 2020 were to exceed your AGI, the CARES ACT allows you to carry forward the excess and utilize that excess amount over the following five tax years, but only at the 60% rate, not the 100% deduction allowable for this year only.

**Relaxed limitations on deductions for the companies/corporations.** For corporate taxpayers, the CARES ACT increases the limitation for cash contributions to qualified charities to 25% of taxable income in 2020. The corporation can also carry forward and utilize any excess amount over the following five years, but at the normal rate in subsequent years.

Additional tax planning opportunities:

**Contribution of publicly traded stock.** Individuals who donate publicly traded stock, if held longer than one year, can deduct the fair market value of the stock as a charitable contribution. Additionally, if the publicly traded stock has appreciated in value, individuals do not need to report the gain as income on their tax return.

**Qualified Charitable Distribution from IRAs.** Individuals who are 70 ½ may exclude up to \$100,000 each year of otherwise taxable IRA distributions if the distribution is paid directly from the IRA to a qualified charity like St. Bernard.

**The above is general guidance only on potential tax saving opportunities in 2020. (Please consult your tax attorney or CPA about how the above can apply to your personal situation.)**
